

SIX HUNDRED AT BANQUET OPENING ENDOWMENT DRIVE

Workers for Creighton
Drive Gather In Force
At Fontenelle

DAHLMAN SPEAKS

Six hundred workers for Creighton university's Building and Endowment campaign gathered at the Fontenelle Hotel on Monday evening for a monster banquet, which served as a "send-off" to the local drive.

Among these workers were four hundred Omaha insurance salesmen, who will conduct the drive in the business districts of Omaha. The residential workers and the Women's organization were also present.

Henry Monsky, prominent attorney and a graduate of Creighton Law school, was toastmaster.

"All that I am, and all that I have and possess, I owe to Creighton university," said Mr. Monsky in his opening remarks.

President McCormick was the first speaker. "Help to make Creighton better and at the same time benefit Omaha," was his suggestion. "Our strongest point of appeal is that we are doing something for nothing. Creighton has been doing something for nothing for forty-four years."

Walter W. Head, chairman of the Board of Regents, spoke on Creighton's drive from a business man's standpoint. "Creighton university, by reason of the things it is doing for the city of Omaha, is a large part of the city," said Mr. Head.

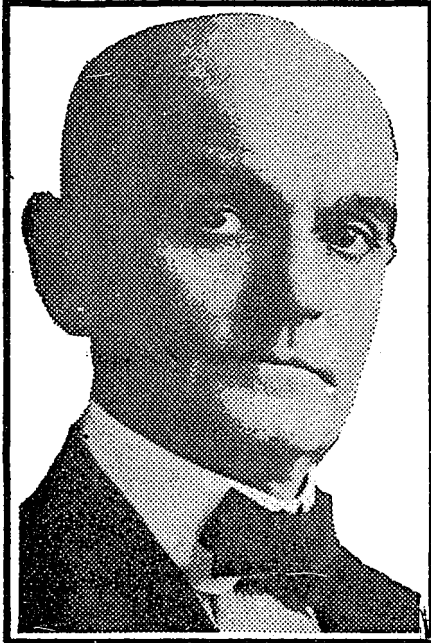
TO PICK NOMINEES FOR HONOR FRATERNITY SOON

Charles Garvey, Athletic Board member, also gave a brief talk, as did Coach Schabinger and Bert Stephens. Plans for the big parade to open the drive were outlined by Stephens. Charles B. Morearty, Union manager, presided. Thunderous applause burst from the 800 students present, when Swanson declared: "I am glad that Nebraska and Creighton have renewed athletic relations, and I, as well as every other student and alumnus of Nebraska, will welcome the day when Creighton and Nebraska again meet on the football field for what should be the gridiron classis of the year."

Swanson, who, as end on the Huskers of a few years ago, played against Chet Wynne, new Creighton head coach, declared that no better selection could have been made. Like Wynne, Swanson was

DOANE COLLEGE PLACES FIRST IN ORATORICAL MEET

Charvat Wins Third Place
In State Oratorical
Contest

Lumer Kuncle of Doane college was given the judges' decision in the thirty-third annual contest of the Nebraska Collegiate Oratorical Association held in Creighton auditorium last Friday evening.

Second place went to William Parkinson of Nebraska Wesleyan university, while Francis C. Charvat of Creighton, who displayed excellent oratorical ability, was awarded the third position.

Mr. Kuncle spoke on, "Backfiring Bolshevism." His speech offered a solution for dealing with the modern evil, which has followed in the wake of the World War.

"The Challenge of the Poppies" was the title of Mr. Parkinson's oration. He gave a vivid picture of the horrors of war, based on personal experiences overseas.

Mr. Charvat denounced the Ku Klux Klan, as an un-American institution. The methods employed by the Klan were likewise scored vigorously by Creighton's representative. Popular prejudice may have played a prominent part in the relegating of Mr. Charvat to third place.

William F. Talbot of Hastings college was the second speaker on the program.

BALLOTING AT LAW SCHOOL CLOSE RACE

Dan Conway was chosen speaker of the Creighton Model House in the annual election of officers held at the Law school last Friday, polling a total of 87 votes to Edward Fogarty's 83, Holden having withdrawn from the race. Mehrens was made Chief Clerk; Reddy, Journal Clerk; and C. R. Emmet, Sergeant-at-Arms.

The election was one of the closest in the history of the Model House and brought to a close a most exciting week of political campaigning on the part of the two fraternities and the independents. Whittaker, the choice of both fraternities for Sergeant-at-Arms, as well as Walter Holden, the independent candidate for Speaker, had taken their names off of the ballot.

The result was a victory for the Gammas, for all of the men elected, except C. R. Emmet, are members of that fraternity. The candidates for offices other than that of Speaker received votes as follows: F. Greene, 57; F. Mehrens, 88; and Vojir, 20 for Chief Clerk; H. Collins, 31; D. Reddy, 87; and A. UNOFFICIAL UNI REPORTS SHOW PROGRESS OF DRIVE

In complete reports from the departments make it practically certain that the University has oversubscribed its \$100,000 quota in the Building and Endowment Fund Campaign. To date the Arts College is the only one that has turned in an official report, but even in the case of the Artsmen, final figures have not been tabulated, and the class presidents are still canvassing their classes.

The largest total subscription turned in so far is that of the Freshman A. B. class, with \$6,600 so far pledged, and prospects of climbing past the \$7,000 mark. The Sophomore A. B.'s have even a better record, as that class has gone over the top 100%. Class-president Jacobberger having collected \$3100 in that class. The Sophomore Pre-medics, under the leadership of Gordon Hammill, have pledged a like amount. The Juniors led by John Flanagan, have high hopes of reaching the 100% mark, and the Seniors are expected to show the way to

ONWARD CREIGHTON

If every Creighton student could have wedged his way into the crowded banquet-room of the Fontenelle Hotel on Monday evening, or if the individual student could have listened to the sentiments expressed by representative men of Omaha on their estimation of Creighton as an asset to the community, no lingering doubt would remain that Creighton has at last come into its own, as far as the city of Omaha is concerned.

This great banquet on the eve of the greatest undertaking ever launched from the Hilltop institution marks a new era in Creighton history,—an era in which the destinies of Creighton university and the City of Omaha will be closely associated.

Whether the drive is a success materially in dollars and cents, we are all deeply concerned; for Creighton needs funds badly for building and endowment, if she is to continue her glorious work with any degree of satisfaction.

Omaha's quota will, without a doubt, be oversubscribed by the time the campaign is finished; but if the set quota has not been reached by the appointed time, the drive will still be a major success. For the goodwill of a community is of untold value to an institution operating in its midst, and the present drive will demonstrate clearly that Omaha is "sold completely" on Creighton as a community asset.

NEBRASKA COLLEGIATE ORATORY

The Nebraska Collegiate Oratorical Association held its thirty-third annual contest at Creighton last week. Creighton is a charter member of the association.

It seems that some interested parties have conceived the brilliant idea of amalgamating the State Debating League and the State Extemporaneous League with the older organization.

As far as Creighton is concerned, amalgamation would be a matter of little consequence. Our interstate debating work is already cared for in a satisfactory manner. But in analyzing the motives of those working for amalgamation, it would seem that some state colleges are seeking this method of entering the state association.

The contest held in the auditorium on Friday evening points to the fact that the time is not yet ripe for amalgamation. The present association has a few things to learn about running a contest, before it takes over two new fields of endeavor. One of these is the devising of a satisfactory and adequate judging system.

Another argument against amalgamation is the present duration of a state contest. If one or two more colleges are added the state will have to be divided into two sections, with two preliminary and one final contest. And traveling is rather expensive.

Present plans for amalgamation, call for one meeting each year to be held at Lincoln. Why change the present system of rotation? In addition one president and vice-president would serve both associations, with a secretary-treasurer, representing each one of the three combined units. We wonder where any college student could be found, who could handle such an exacting position as president of the combined associations.

Mr. Landes is a contractor with a real estate and loan office at Wooster, Ohio. He has been somewhat active in politics but never held a prominent office. He is said to have made a special study of farm values.

The appointments were made under a new provision of the law enacted just before the adjournment of congress enlarging the membership of the board.

Merton L. Corey, 40, general attorney for the Federal Land bank of Omaha, now in Washington, has been appointed a member of the farm loan board at a salary of \$10,000 a year, according to information received at the Federal Land bank this morning. Mr. Corey is one of the three democratic members of the board, the other three being republicans.

The Federal Farm Loan act, which was signed by President Harding yesterday, provides for increasing the board from four to six members. Mr. Corey has been in Washington for the last two months working on this act and appearing before committees of congress in behalf of increasing the loan limit of the twelve federal land banks.

Since the organization of the Federal Land bank of Omaha, Mr. Corey has been its general attorney at a salary of \$6,000 a year. He is a graduate of the University of Nebraska law school, and has practiced law at Clay Center and Hastings. While at Clay Center he was county attorney.

For the last two years Mr. Corey has been traveling in many states explaining the workings of the Federal Land bank system. A year ago he began advocating the increase of the loan limit. He appeared before the general convention of the American Bankers' association last year and before a number of state bankers' conventions.

Mr. Corey is expected to return to Omaha within the next two weeks to make plans to take up his residence in Washington. His wife and one child are with him now.

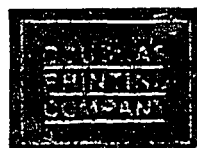

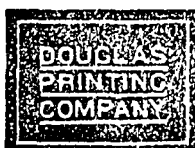

ALL COLLEGE ORATORS CHOOSE HASTINGS

Annual Convention Held at Creighton Law Building

The Nebraska College Oratorical Association held its annual convention in the Creighton Law building on Friday afternoon, March 2. Eight delegates from as many colleges transacted the business of the association. George Koehn, retiring president, presided over the meeting.

After the transaction of the customary business, the delegates began an unmerciful attack on the present constitution of the association, led by Professor Scott of Nebraska Wesleyan. The final decision reached was that the constitution should be revised.

A committee representing the Nebraska State Debating League also waited upon the convention. This committee suggested that the two organizations be amalgamated into one, which would foster debating, oratory, and extemporaneous speaking contests. Those familiar with this plan consider it as a move by Kearney Normal and another small college at Central City towards membership in the state association. The offer was favorably received, and the Chair appointed a committee, composed of delegates from Nebraska Wesleyan university, Doane college, and Creighton university to confer with the committee from the Debating League. John J. Flanagan represented Creighton on this committee.

The two committees held a brief meeting after the convention. It was decided that each committee member from the Nebraska Oratorical Association should submit a tentative constitution at a meeting to be held in Lincoln on March 22. A permanent constitution will be adopted at that time.

Mr. Miles J. Martin, coach of oratory and debating at Hastings college, is chairman of the joint committees on amalgamation and the drawing up of a new constitution.

It was decided that next year's oratorical contest is to be held at Hastings college.

Mayor James C. Dahlman made an eloquent appeal for Creighton university and the cause of higher education. She also mentioned the splendid work that Miss Mona Cowell, LL.B., '18, was doing for the drive.

F. N. Croxson, Manager of the Omaha office of the Equitable Life of N. Y., gave the drive workers a fitting send-off, with a snappy speech. "What's good for Creighton university is good for Omaha," was the gist of Mr. Croxson's argument. He pledged hearty support on the part of the four hundred insurance solicitors.

A short film depicting Creighton university of today and tomorrow was shown at the banquet. The Chenoweth Film Co. prepared the film. The Fontenelle orchestra played during the banquet.

Dr. P. T. Conlon called on all the members of the basketball team in his "quiz," Monday. He then said: "I just wanted you boys to know that these men are good students, as well as basketball players."

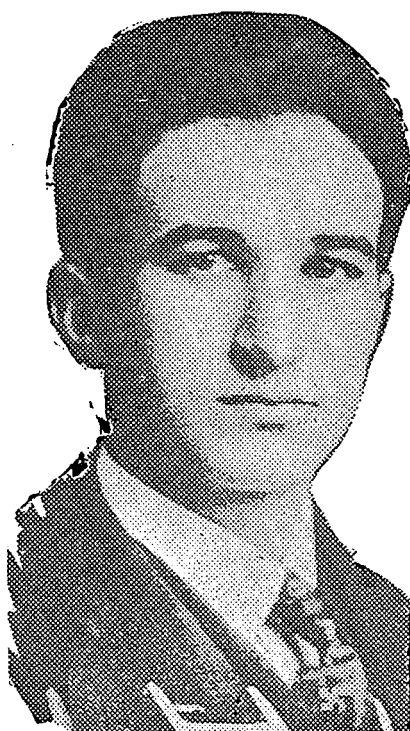
As to where the club would go on its trip, he responded: "Well, that is doubtful. You see I have had this job for only twenty-four hours, and twenty-four hours is a rather short time."

Creighton Cagers Trim Nebraska 46-24

BLUE VARSITY TROUNCES HUSKER QUINTET IN SPECTACULAR CONTEST

Hilltop Team Plays Stellar Basketball—Usher Husker Star

Creighton's basketball machine, showing about one hundred per cent improvement since their clash with Kansas eight weeks ago, easily walloped the Nebraska Cornhuskers Saturday night 46-24.

At the start it looked as if it would be a nip and tuck affair.

Usher opened the scoring with a successful foul shot. Trautman tied the score by duplicating Usher's feat. Usher again gave the Cornhuskers a lead with a beautiful field goal from a difficult angle; he followed this with another perfect foul shot, bringing Nebraska's total to 4 points.

During the next five minutes Lovely, Trautman and Mahoney, with a wonderful display of offensive work, completely bewildered the Cornhusker defense and ran the Creighton score up to eleven. At this juncture Nebraska called time out.

With time in both teams showed a very complete reversal of form. During the next six minutes with Usher and Warren leading in brilliant attacks which usually ended with perfect field goals, the Scarlet and Cream snatched the lead from the Blue. Score 13-11. Lovely now called time for Creighton.

Play had hardly been resumed when Mahoney knotted the count with an uncanny left handed shot.

With eight minutes to play in this half, Lovely and Mahoney brought the house down with some rapid-fire shooting. These two men with the aid of field goals by Trautman and Speicher gave the Blue a ten-point lead which proved too much for the Nebraskans to overcome. The score at the half was 26-16.

The second half was opened by Mahoney with a short field goal. Crozier gave the people from Lincoln a chance to exercise their lungs, by caging one from mid-floor.

About this time the diminutive Johnny Trautman, who had been unlucky in shooting during the first half, started to find the basket. Three field goals by Johnny with two apiece by Mahoney and Lovely placed the Hilltoppers on easy street for the evening.

Warren and Usher, who were doing the bulk of the work for Nebraska, managed to cage an occasional field goal but their efforts were in vain against the commanding lead piled up by Lovely, Mahoney and Trautman.

During the last few minutes of play the Cornhusker defense was scattered and as a result the Blue wound up the evening with a twenty-two point lead. Score 46-24.

The offensive playing of both teams was much better than the defensive. If the Blue defense had shown as much against Nebraska as it had against

Marquette the Cornhuskers would have scored about four field goals. At that, no defense was necessary with Lovely, Mahoney and Trautman going as they were.

Usher and Warren proved to be two of the best men seen on the local court this season. Warren's all around play scintillated. Usher's elusiveness and basket shooting won the admiration of the large crowd.

After this we will order big crowds for "Ike" Mahoney. The bigger the crowd the better "Ike" plays. His marvelous shooting disheartened Cornhusker followers from the start.

Captain Warren gave a great exhibition at center, but "Ike" Mahoney overshadowed Warren's best efforts.

Will we raise two million dollars in this campaign? Can Creighton beat Nebraska?

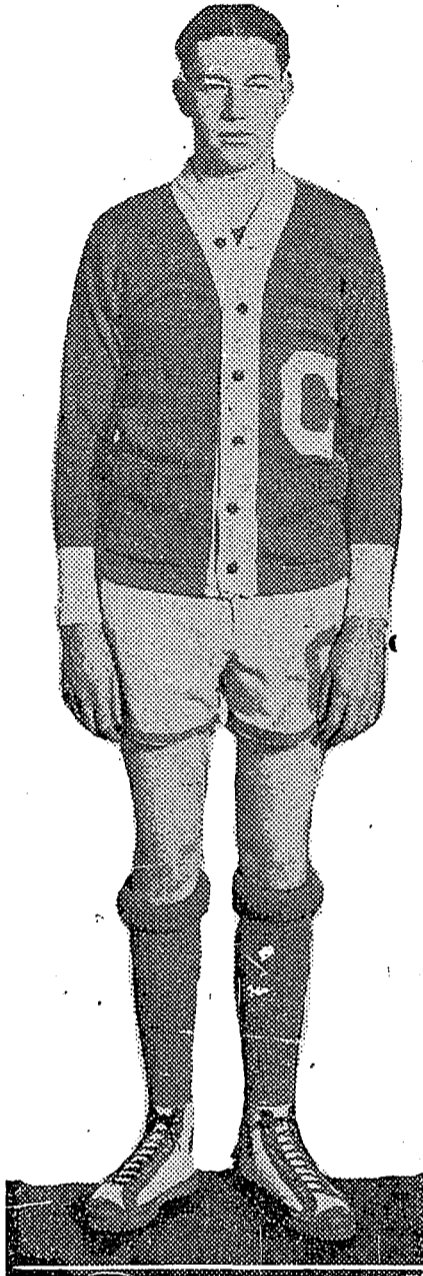

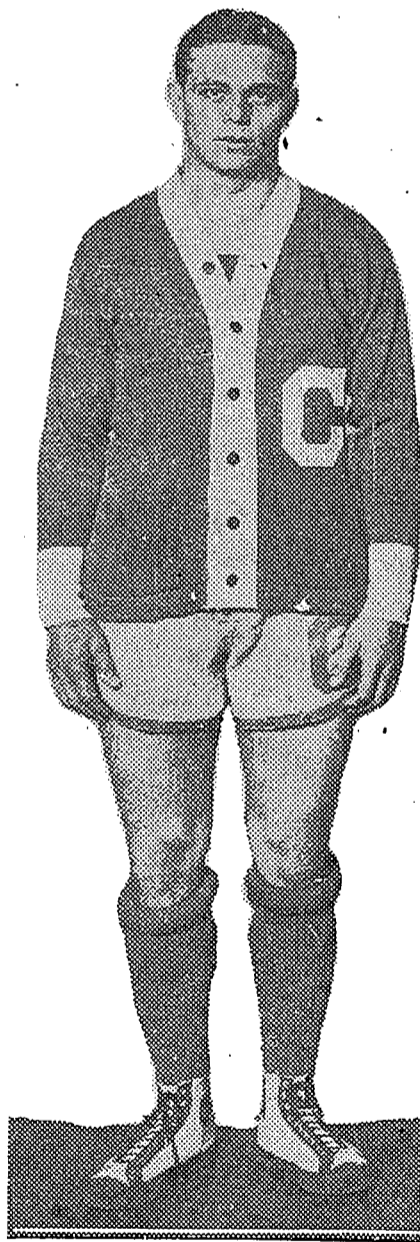
scoring burden fell on Johnny and he made a wonderful showing when it was needed the most. Johnny was there and over, all the time.

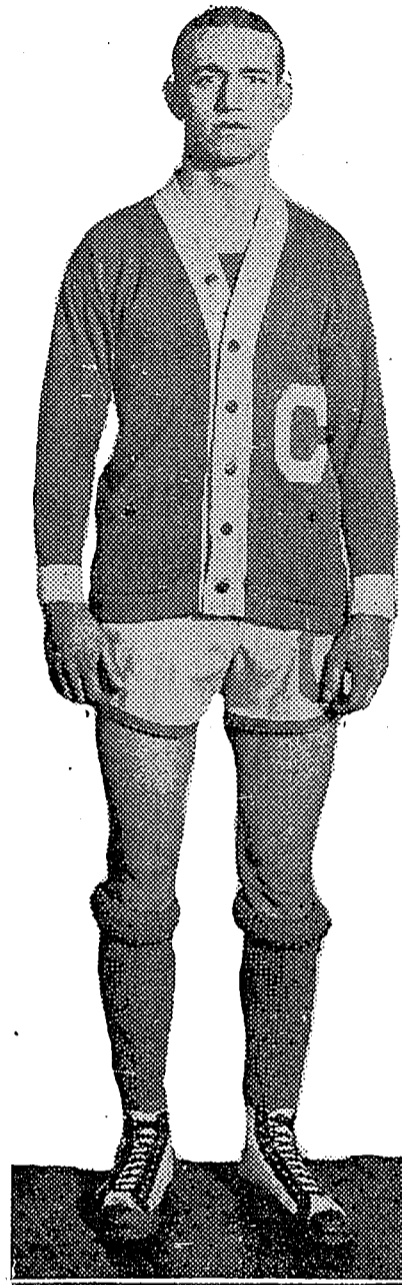

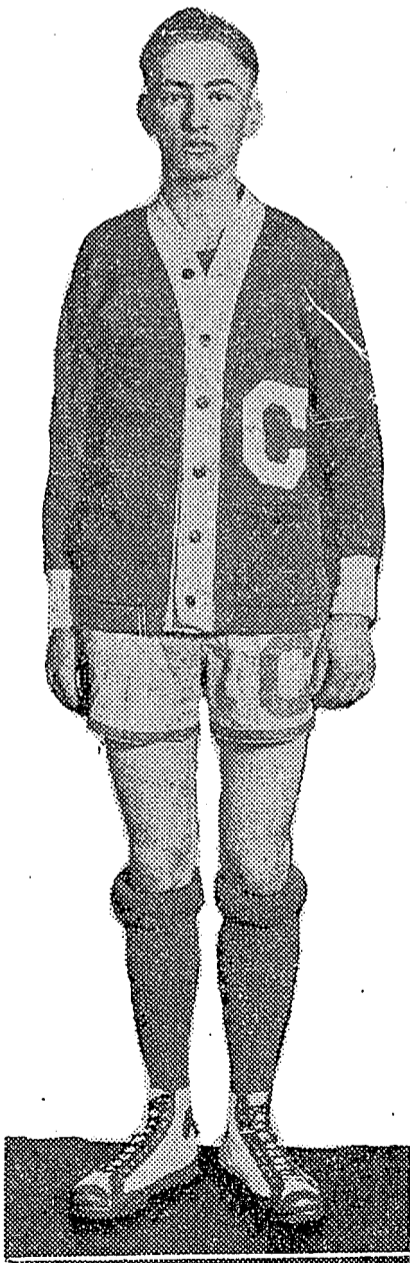

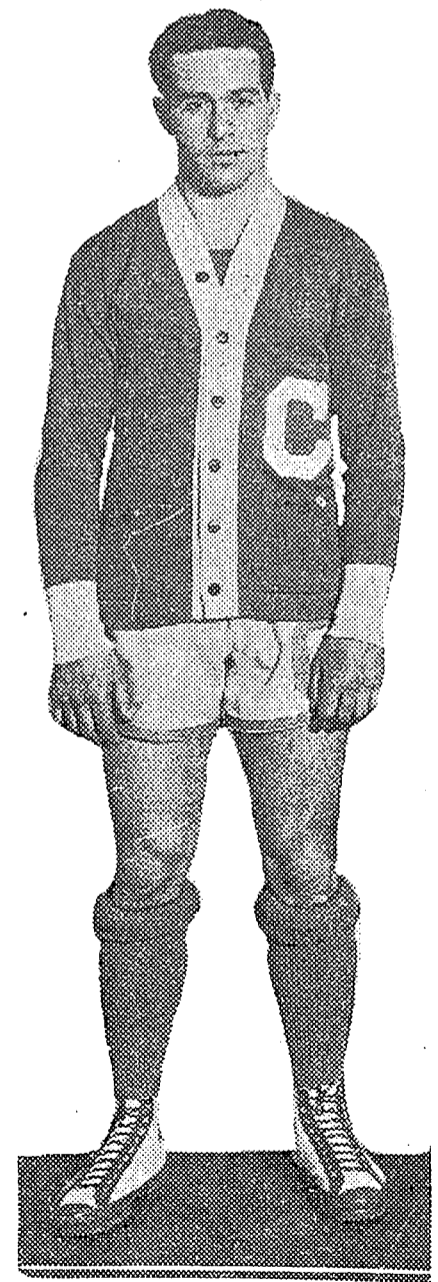
